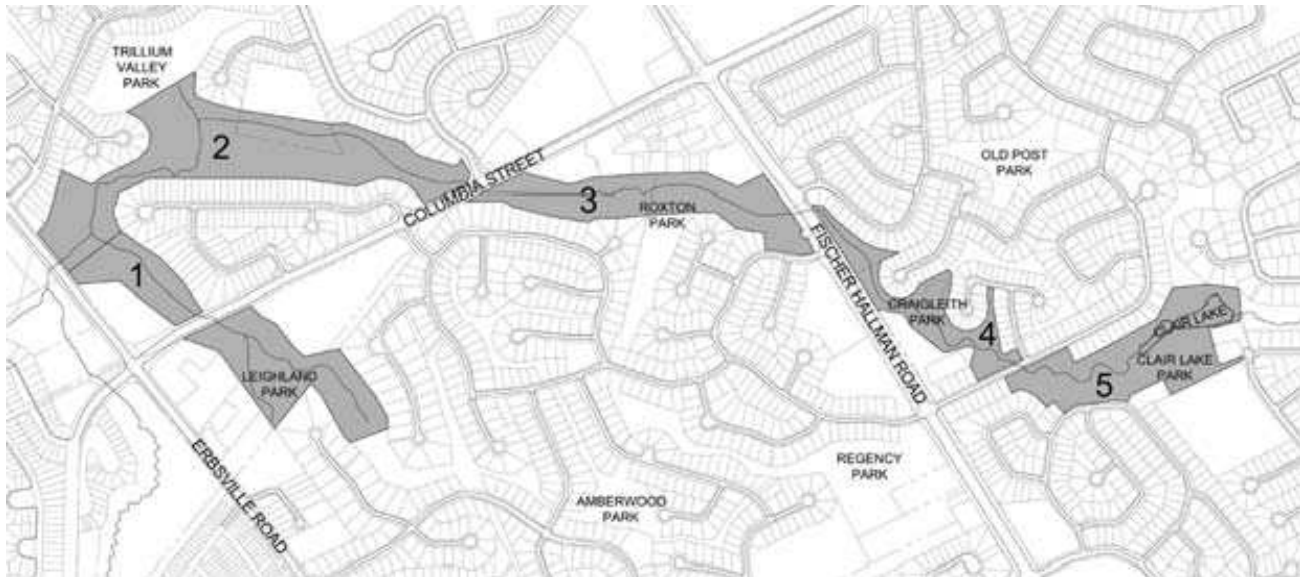


**PUBLIC NOTICE**  
**NOTICE OF PRE-CONSTRUCTION PUBLIC INFORMATION CENTRE**  
**NORTH CLAIR CREEK AND CLAIR LAKE REHABILITATION**

The City of Waterloo is proceeding with the Construction of the rehabilitation work for Reaches 2, 3 and 5 in conformance with the finalized detailed design. Reaches 2 and 3 pertain to North Clair Creek between Erbsville Road and Fischer Hallman Road, while Reach 5 pertains to Clair Lake. (see map)



In 2005, a Class Environmental Assessment (EA) was prepared for Reaches 1 through 5 providing recommendations for rehabilitation works along North Clair Creek and Clair Lake Park. These recommendations focused on improving water quality and reducing channel erosion within the system. In 2009, a Technical Evaluation was performed to determine if the Class EA recommendation of an off-line lake in Reach 5 could satisfy design criteria established by the community and endorsed by City of Waterloo Council. The off-line lake was determined to **not be** technically feasible due to environmental, ecological and social limitations. Through a Class EA Addendum in Reach 5, a conceptual on-line lake with enhanced habitat and improved water quality was proposed and approved by City of Waterloo Council in 2010.

In 2011, the detailed design for implementation of the rehabilitation work within Reaches 2 and 3 of North Clair Creek and of an online pond with enhancements within Reach 5 was finalized and the project is now moving into the construction phase.

The construction sequencing plan and schedule has been prepared and will be available for public viewing and comment.
